COVID-19 PROTOCOL

Our mission at My Fencing Club as always is to create a safer space to enjoy the sport, and so ensuring the safety of our community, our students & staff remains our top priority. We want to keep you updated about the precautions we are taking in the face of COVID-19.

What we're doing:

To maximize social distancing and create a safe space for fencers and coaches, we will be following the [COVID-19 Return to Play Page](#) published by Ontario Fencing Association. Our safety measures include, but are not limited to the following:

- There will be no sharing of equipment other than weapons.
- Changing rooms will not be used during lessons. Come to the club dressed in clean workout clothing. Clothing should be suitable for public display and to wear under fencing uniforms, such that uniforms can be put on before entering the club without the need for changing rooms.
- All fencers must bring their own water bottle.
- Shaking hands during or after fencing activities is no longer allowed.
- No food sharing will be allowed.
- There will be limited participation up to 12 students.
- Students may spend a maximum of 10min prior/after the class in the gym.

Prior to attending the camp, participants and the staff must complete a pre-visit screening form on the day of their visit before accessing facilities. Parents or guardians accompanying participants into the program areas must also complete a pre-screening in order to enter our facilities.

This will include the following:

- Self-monitor and be symptom free for at least 10 days prior to the camp.
- Stay home if you have had close sustained contact in the last 14 days with anyone who was sick or known or believed to have COVID-19.
- Stay home if you are sick or do not feel well.
- Provide a note from a doctor stating that you are cleared to participate in club activities if you have had a case of COVID-19.

Any participants or the staff who become ill with COVID 19 symptoms while participating in the camp must go home immediately to self-isolate. Other participants who came in close contact with the infected individual may be required to self-isolate.

Proof of Vaccination Requirements:

Participants aged 5-11 years must show proof of their 1st dose by January 17 and their second dose by March 14, 2022.

Participants ages 12 years or older have the required vaccinations (2 doses +14 days) in order to participate.

Parents or guardians accompanying participants into the program areas must have the required vaccinations (2 doses +14 days) in order to enter our facilities.

Present your enhanced vaccine certificate with QR code accompanied by a valid government ID.

WAIVER

I (the undersigned) do hereby grant permission for my child,

to attend the Beginner Fencing Camp (Camp) at My Fencing Club. In consideration of my/our child/ren's participation in My Fencing Club sports and camp activities:

- I/we grant permission to My Fencing Club or its representative to act on my/our behalf in case of a medical emergency, and to transport my/ our child/ren to a local doctor or hospital for medical treatment if necessary.

- I/we consent to the use by My Fencing Club of images of my/our child/ren in photographs and videos showing their participation in camp activities at My Fencing Club. I/we agree that My Fencing Club may use such photographs or videos, without payment by My Fencing Club, for promotional or instructional purposes or for publication by the news media.

- My Fencing Club is committed to respecting the personal privacy of individuals. All personal information contained on this form is collected and protected under the Federal Personal Information Protection and Electronic Documents Act (PIPEDA).

Information is not disclosed to anyone except My Fencing Club personnel who need the information to carry out the responsibilities of their job. As a result, I/we consent to the collection, use and retention of this personal information by My Fencing Club in order to process this registration form, collect fees, record any medical information (if required) and inform parents of future camp activities. - I/we understand that My Fencing Club has the right to remove campers from registered sessions if they do not conduct themselves in a respectful and behaved manner. It will be at My Fencing Club's discretion, based on the severity of the behavioural incident, whether the camper may partake in any further camp weeks in which they may be registered or whether they may register for camps again in the future.

- I/we agree to release, discharge, indemnify and save harmless My Fencing Club, its proprietors, participants and employees, from and against all claims or proceedings arising as a result of any accident, injury, or otherwise sustained by my/our child/ren arising from participation in any camp activities, except in the case of gross negligence.

- No refunds will be offered for the camp deposit or camp fee.

- Camp fees are for the entire camp session; not a day-by-day basis. My Fencing Club will therefore not refund fees for days missed for any reason.
